General Rules and Directions for the Guidance of Contractors

1. All works proposed for execution by contract will be notified and notice inviting tenders pasted on board hung up in the office of and signed by Divisional Forest Officer, Awadh Forest Division, Lucknow. This form will state the work to be carried out as well as the date for submitting and opening tenders and the time allowed for carrying out the work, also amount of earnest money to be deposited with the tender, the amount of the security deposit to be deposited by the successful tenderer and percentage if any to be deducted from bills. The set of contract documents consisting of copies of drawings and details of the proposed works, specifications of various items of work and a form of the printed conditions of contract together with the form of agreement to be used, signed for purpose of identification and approved by the Divisional Forest Officer, Awadh Forest Division, Lucknow who is the authority competent to make the contract, shall be available for public inspection at the office of the Divisional Forest Officer, Awadh Forest Division, Lucknow, 21/475, Indira Nagar, Lucknow during office hours.
2. Any contractor who submits the tender shall fill up the prescribed form of tender and sign the same. In the event of tender submitted by a firm, it must be signed separately by each member thereof or in the event of the absence of any partner it must be signed on his behalf by person holding a power of attorney authorizing to do so.
3. Receipt of the payment on account of work when executed by a firm must also be signed by the several partners except where 'the contractor' is described in their tenders as a firm by one of the partners or by some other person having authority to give effectual receipt for the firm.
4. Tenders, which propose alteration in the work specified in the form of Notice Inviting Tenders or in the time allowed for carrying out the work or which contain any other conditions of any sort or which are not accompanied by the deposit of Earnest Money notified, will be liable to rejection. Tenders shall have name of the work to which they refer written outside the envelope.
5. The receipt of an accountant or clerk of the earnest money paid by the Contractor will not be considered as any acknowledgement by the Divisional Forest Officer, Awadh Forest Division, Lucknow and the contractor shall be responsible for seeing that he procures a receipt signed by the Divisional Forest Officer, Awadh Forest Division, Lucknow.
6. The memorandum of work tendered for shall be filled in and completed in the office of the Divisional Forest Officer, Awadh Forest Division, Lucknow, 21/475, Indira Nagar, Lucknow.
7. If a contractor writes different rates in words and figures in his tender, the lower of two rates shall be deemed as the correct and binding.
8. Unit of rates as shown in Bill of Quantity should be carefully noted as rates once given by the contractor shall remain unaltered and no change on any account shall be entertained after the tender has been opened.
9. Walls of one brick shall be measured as 23.0 cm thick and each half brick thickness shall be considered to increase or decrease the wall thickness by 11.5 cm.

1. Tenders are hereby invited on behalf of the Awadh Forest Division, Lucknow through registered post/speed post for the following works:-

2. Sealed tenders will be received till 05th September 2011 upto 3:00 p.m. in the office of Divisional Forest Officer, Awadh Forest Division, Lucknow and will be opened by him or his authorized representative as follows:
 - a- Pre-Qualifying bid (Technical bid) on 05th September at 4:00 pm at office of Divisional Forest Officer, Awadh Forest Division, Lucknow.
 - b- Financial bid on 20th September 2011 at 03:00 p.m at office of Divisional Forest Officer, Awadh Forest Division, Lucknow.
3. Tenderers or their representatives (limited to one in number) who desire to be present at the time of opening tender will be permitted to do so.
4. The work must be completely finished in accordance with the contract document within 15 calendar months from the date of receipt of order to start work.
5. Copies of the drawings and other documents pertaining to the work (signed for the purpose of identification by the accepting authority or his authorized representative) will remain open for inspection at the office of the Divisional Forest Officer, Awadh Forest Division, Lucknow during normal working hours on every working day. Complete sets of blank tender forms along with other documents can be obtained from the office of the Divisional Forest Officer, Awadh Forest Division, Lucknow on every working day during office hours on or before 03th September 2011 at an inclusive charge of Rs. 2392/- only.
6. Each tender must be accompanied by a deposit of Rs.13.54 lac. (Rupees thirteen lac fifty four thousand only) as Earnest Money in the form of FDR/ CDR from any Nationalized Bank/Scheduled Bank duly pledged in favour of Divisional Forest Officer, Awadh Forest Division, Lucknow .The tenderer will not be entitled to interest earned upon the earnest money. Provided that if the tenderer is an interested contractor, he will be entitled to tender for the category for which he is enlisted and such tenders can be submitted by him against the general security deposited by him and further deposit of earnest money at the time of consideration of the tender will not be necessary.
7. Trade Tax / Sale Tax /Octroi and other taxes on material, if any, in respect of this contract shall be payable by the contractor and the Divisional Forest Officer, Awadh Forest Division, Lucknow will not entertain any claim whatsoever in this respect.

8. (i) No tenderer shall be permitted to tender for works if his any near relative is posted in the Awadh Forest Division, Lucknow or Project Management Unit, U.P. Participatory Forest Management and Poverty Alleviation Project, U.P., Lucknow.
- (ii) The tenderer shall clearly specify in their tender whether or not any of their relatives are in the service of Awadh Forest Division, Lucknow or Project Management Unit, U.P. Participatory Forest Management and Poverty Alleviation Project, U.P., Lucknow and if so their name and designation should be given.
- (iii) Failure on the part of tenderer to correctly or completely disclose the names, designation and places of posting as in sub-Clause (ii) above would render the earnest money/security deposit of the tenderer liable to be forfeited and the contract liable to be cancelled.

Explanations –

- (a) The expression near relative used in this clause means father, mother, sister, brother-in-law, son, daughter, father-in-law, mother-in-law and first cousins of self, wife, son, daughter father and mother.
 - (b) The expression tenderer used in this clause includes any partner or director of the tendering firm or company, as the case may be.
9. The tenderers are advised to see the site of the work and they will be deemed to have familiarized themselves with the scope of work, local conditions, drawings, specifications, conditions of contract before submitting their tenders.
 10. Tender shall remain open for acceptance for a period of ninety days from the date of opening of tenders subject to the following condition:-
“In consideration of Divisional Forest Officer, Awadh Forest Division, Lucknow having treated the tenderer to be an eligible person whose tender may be considered, the tenderer shall agree to the condition that proposal in response to this invitation shall not be withdrawn by the tenderer within ninety days from the date of opening of tender. The earnest money deposited by him may be forfeited by the Divisional Forest Officer, Awadh Forest Division, Lucknow in the discretion of the latter.”

- Note:**
1. If subsequent to the submission of tender, any tenderer amends, alters or modifies the consent of his tender which are not acceptable to the Divisional Forest Officer, Awadh Forest Division, Lucknow, then for purpose of this condition the tenderer shall be deemed to have withdrawn his proposal.
 2. The tenderer will have to furnish on an agreement for Validity of Rates on Non-judicial Stamp of Rs. 100/- and by affixing Revenue Stamp of Rs. 1.00 on the format supplied to the tenderer alongwith tender papers.
11. Canvassing in any form in connection with the tenders is strictly prohibited and the tenderers who resort to canvassing, their tenders are liable to be rejected.

12. All rates shall be quoted only on the blank form of the tender supplied by the Divisional Forest Officer, Awadh Forest Division, Lucknow. Tenders with rate quoted on private papers will not be considered.
13. The notice inviting tender shall form part of the contract when concluded.
14. (a) On acceptance of the tender, the successful tenderer must deposit the required amount of security deposit within seven days of acceptance being conveyed to him. The earnest money of the successful tenderer shall be converted and adjusted against security deposit. Security amount of 10% at the bonded cost, must be deposited by the contractor at the time of the execution of the contract bond, which shall be with the Divisional Forest Officer, Awadh Forest Division, Lucknow till six months of the date of the completion of the work.

1. R.C.C. shall be laid only on Pucca Steel shuttering or Ply Wood shuttering. The responsibility for clear and smooth finish of R.C.C. is fully the responsibility of the contractor.
2. Mini batch mix plant shall be necessarily used for mixing of concrete, concrete mixer can be used for smaller works.
3. Vibrator shall be necessarily used for compaction of cement concrete, hand compaction shall not be allowed.
4. The contractor shall have to get all the materials used by him to be tested at approved laboratory at the cost of contractor.
5. Payment for the work done shall be made only after furnishing the test report.
6. Hamirpur /Banda sand of FM 1.5 to 2.0 shall only be allowed to be stacked at the site for plaster/brick work & 2.00 to 3.60 for concrete work. Any sand having FM less than 1.5 shall not be allowed under any circumstances at the site of work.
7. Any sand (Hamirpur / Banda) of FM less than 1.5 if found at the site of work dump with such sand shall be considered below specification and whole work shall be rejected.
8. Defective work done on account of contractor's fault shall be dismantled at his own cost and the cost of materials and labour (as per UP PWD norms) shall be recovered from his bill.
9. The Project-in-Charge has full power to employ Bhisti or any other arrangement on the work without any notice to the contractor if the curing is inadequate. The cost of curing shall be recovered from the bill of contractor.
10. The quantities given in the Bill of Quantity are liable to wide variations (increase or decrease) for which no claim whatsoever shall be entertained.
11. The contractor shall have to make arrangement for shuttering, centering and bullies etc. for the roof slab and scaffolding in sufficient quantity as per direction of Project-in-Charge.
